## Dollar General Survey Sweepstakes 2024-25 OFFICIAL RULES

Two (2) methods of entry are as follows:

After the completion of the survey and submission of Entrant's information at the Website, an Entrant will receive one (1) entry into the applicable Entry Period (based on the date in which the survey is completed).
